

Table of fees and charges fixed by [ARRETON PARISH COUNCIL](#) under the provision of the Local Authorities Cemetery Order 1977 **effective from 1st April 2026**

The fees and charges set out below are in two parts. Table A applies to the inhabitants of the Parish of Arreton. Table B applies in all other cases.

The fees and charges in Table A apply where the person to be interred or in respect of whom the right is granted is, or immediately before their death, was an inhabitant of the Parish of Arreton, including that part of Rookley Parish, formerly part of the Parish of Arreton.

The fees and charges in Table B apply in all other cases.

An exception can be made and Table A fees applied at the absolute discretion of the Burial Authority where it is supplied with information that although the deceased was not an inhabitant of the Parish at the date of death they had been for a substantial period of their life and/or had a long-standing family connection to the Parish. Cases will be decided on an individual basis and the Burial Authority's decision is final.

PART 1 - INTERMENTS

The fees and charges in the part – do NOT include the digging of the grave

For interment in an earthen Grave

1. of the body or cremated remains of a still-born child or child of 17 years or under	No charge	No charge
2. of the body of a person of 18 years or over	£280	£750
3. of the cremated remains of any person of 18 years or over	£150	£300

Interment of cremated remains is conditional upon the prior grant of exclusive right of burial.

PART 2 - EXCLUSIVE RIGHT OF BURIAL IN EARTHEN GRAVES

1. For the exclusive right of burial in an earthen Grave 2.75 metres by 1.5 metres	£280	£750
2. For the exclusive right of burial in an earthen Grave 1.5 metres by 1.5 metres	£130	£300

Exclusive rights of burial are granted for 100 years. The fees indicated for the various heads of Part 2 include the Deed of Grant and all the expenses thereof.

PART 3 - MONUMENTS, GRAVESTONES AND MONUMENTAL INSCRIPTIONS

For the right to erect or place on a grave in respect of which the exclusive right of burial has been granted

For any other memorial please apply to the Burial Authority for fee information.

This fee includes the first inscription.

For each inscription after the first, a fee of £25 (Table A) or £50 (Table B) is payable.

PART 4 - OTHER FEES

Burial Register – Copy of Certified Extract fee of £50.

Attendance by a representative of the Burial Authority for the purposes of supervision under Regulation 10 of the Regulations Relating to Gore Cemetery and Arreton Churchyard fee of £50.
